#### **Purpose of Inspection**

The RHRA conducts routine inspections as set out in section 77(3) of the *Retirement Homes Act, 2010* (the "RHA").

### NON-COMPLIANCE

### 1. The Licensee failed to comply with O. Reg. 166/11, s. 23; Behaviour management.

Specifically, the Licensee failed to comply with the following subsection(s):

**23. (1)** Every licensee of a retirement home shall develop and implement a written behaviour management strategy that includes,

(a) techniques to prevent and address resident behaviours that pose a risk to the resident or others in the home;

(b) strategies for interventions to prevent and address resident behaviours that pose a risk to the resident or others in the home;

(c) strategies for monitoring residents that have demonstrated behaviours that pose a risk to the resident or others in the home;

#### **Inspection Finding**

The inspector reviewed resident documents for three residents with behaviors that pose a risk to the resident or others. The home failed to provide evidence that a behavior management strategy had been developed which includes, techniques and interventions to address and prevent the behaviors, and a strategy for monitoring the residents that have demonstrated the behaviors.

#### Outcome

The Licensee must take corrective action to achieve compliance.

2. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Plan of care.

Specifically, the Licensee failed to comply with the following subsection(s):

**62. (1)** When a resident commences his or her residency in a retirement home, the licensee shall, within the prescribed times, ensure that the resident is assessed and that a plan of care is developed based on the assessment and in accordance with this section and the regulations.

### **Inspection Finding**

The inspector reviewed resident documents for three residents and found that the Licensee failed to provide evidence that a plan of care was developed based on the assessment as required in the regulation.

### Outcome

The Licensee must take corrective action to achieve compliance.

## 3. The Licensee failed to comply with O. Reg. 166/11, s. 27; Infection prevention and control program.

Specifically, the Licensee failed to comply with the following subsection(s):

27. (5) The licensee of a retirement home shall ensure that,

(0.a) any guidance, advice or recommendations given to retirement homes by the Chief Medical Officer of Health are followed in the retirement home;

## **Inspection Finding**

During the inspection the inspector reviewed records relating to the daily temperature screening of residents. The inspector found the that the Licensee was unable to provide evidence of daily temperature screening for residents, as required by the Chief Medical Officer of Health guidance.

### Outcome

The Licensee has demonstrated it has taken corrective action to achieve compliance.
