About Routine Inspections

A routine inspection, performed by an RHRA inspector, is a physical inspection of a licensed retirement home. During a routine inspection, an RHRA inspector will walk through the home, speak to residents and staff, observe care services and conditions in the home, and ensure the licensee's management and staff follow mandatory policies and practices designed to protect the welfare of residents.

Following a routine inspection, the RHRA inspector prepares a draft inspection report which is sent to the licensee. The draft report may include instances where the licensee has failed to meet the standards of the *RHA*. If included, the licensee can respond to these instances and is strongly encouraged to inform RHRA of its plans to meet the standards of the *RHA*.

Following the draft report, the RHRA inspector prepares this final inspection report, incorporating any response from the licensee with their plans to meet the standards of the *RHA*. The most recent final inspection report must be posted in the home in a visible and easily accessible location. All final inspection reports from the previous two years must also be made available in an easily accessible location in the home. The licensee must provide a copy of this report to the home's Residents' Council, if one exists.

In addition to inspection reports, RHRA may provide information to a licensee to encourage improvements of their current practices.

If the licensee repeatedly does not meet the required standards, RHRA may take further action.

Focus Areas

During a routine inspection, an inspector will focus primarily on a set number of areas which have been identified as related to the health, safety and wellbeing of resident, and may take various actions to determine whether the licensee is compliant with the RHA in relating to the areas. The areas listed in this section are ones which an inspector has identified as non-compliant.

Focus Area #1: Behaviour Management

RHRA Inspector Findings

The inspector identified a resident who demonstrated responsive behaviour towards another resident. The evidence demonstrated that the Licensee failed to implement their behaviour management strategy. Specifically, the the plan of care for the resident who demonstrated the behaviours was not updated with effective/ ineffective interventions, there was no evidence of an investigation of the incident by the Director of Health and Wellness, no evidence of a review of the behaviour management tracking, and no efforts with the substitute decision maker, family or physician to undertake psychogeriatric consultation. The Home failed to implement the behaviour management strategy.

Outcome

The Licensee submitted a plan to achieve compliance by Fri Nov 24 2023. RHRA to confirm compliance by following up with the Licensee or by inspection.

Focus Area #2: Emergency Plan

RHRA Inspector Findings

The inspector reviewed the Licensee's records of testing for their emergency plans in 2022. The evidence demonstrated that testing for situations involving the loss of essential services, a missing resident, a medical emergency and a violent outburst were not completed annually. In addition, there was no evidence of regular testing of the emergency kit of supplies, equipment and resources, as prescribed. The Licensee failed to ensure that testing was completed, as required.

Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by following up with the Licensee or by inspection.

Focus Area #3: Maintenance

RHRA Inspector Findings

While walking through the Home, the inspector was able to enter an unlocked area on the secure memory care unit and was able to access a variety of cleaning agents, including one that was designated as a hazardous substance. The Licensee failed to keep hazardous substances inaccessible to residents at all times, as prescribed.

Outcome

The Licensee submitted a plan to achieve compliance by Fri Dec 01 2023. RHRA to confirm compliance by following up with the Licensee or by inspection.

Additional Findings

During a routine inspection, an inspector may observe areas of non-compliance that are not related to the standard focus areas. In these cases, an inspector may cite the home for these contraventions at the time of this inspection. In addition, an inspector may follow-up on findings of non-compliance from previous inspections. Where the licensee is unable to demonstrate they have come into compliance or maintained compliance, an inspector may cite the home for these repeat contraventions at the time of this inspection.
