Purpose of Inspection

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

NON-COMPLIANCE

1. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 68; Restraints prohibited.

Specifically, the Licensee failed to comply with the following subsection:

<u>s. 68. (1)</u> No licensee of a retirement home and no external care providers who provide care services in the home shall restrain a resident of the home in any way, including by the use of a physical device or by the administration of a drug except as permitted by section 71.

2. The Licensee failed to comply with O. Reg. 166/11, s. 53; Restraint by a physical device.

Inspection Finding

The Inspector found that full bed rail restraints were being used for two residents of the home. There was no evidence to verify that these restraints had been ordered by a member of the College of Physicians and Surgeons of Ontario (CPSO) or College of Nurses of Ontario (CNO). One of the resident's charts contained an assessment conducted by an occupational therapist on March 5, 2013, which stated the use of full bed rails increased the risk of entrapment for the resident. Despite this assessment, the home continued to use full bedrails for this resident. Further, there was no evidence that either of the residents were monitored or supervised on an ongoing basis, reassessed by a member of the CPSO or CNO, or had their substitute decision makers consent to use of the devices.

Outcome

Director Waning Letter issued.
