Purpose of Inspection

The RHRA received a report under section 75(1) of the *Retirement Homes Act, 2010* (the "RHA").

## NON-COMPLIANCE

## 1. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 60; Standards. The Licensee failed to comply with O. Reg. 166/11, s. 35; Assistance with bathing.

Specifically, the Licensee failed to comply with the following section:

**<u>s. 35.</u>** If one of the care services that the licensee or the staff of a retirement home provide to a resident of the home is assistance with bathing, the licensee shall ensure that,

(b) the resident is bathed in a manner that respects the resident's privacy and preferences, except to the extent that these are contraindicated by a medical condition.

#### **Inspection Finding**

Inspection confirmed that a resident of the retirement home was not bathed by a staff member in a manner that respected the resident's preferences.

#### Outcome

Corrective action taken.

## 2. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 67(5); Contents.

Specifically, the Licensee failed to comply with the following subsection:

<u>s. 67. (5)</u> At a minimum, the policy to promote zero tolerance of abuse and neglect of residents shall,
(d) contain an explanation of the duty under section 75 to report to the Registrar the matters specified in that section.



## **Inspection Finding**

On the date of inspection, the Inspector confirmed that the policy for promoting zero tolerance of abuse and neglect was not in alignment with the *RHA*.

#### Outcome

Corrective action taken.
