Purpose of Inspection
The RHRA received a report under section 75(1) of the <i>Retirement Homes Act, 2010</i> (the "RHA").


NON-COMPLIANCE
<p><b>1. The Licensee failed to comply with O. Reg. 166/11, s. 40; Provision of a meal.</b></p> <p>Specifically, the Licensee failed to comply with the following subsection(s):</p> <p><b>40.</b> If one of the care services that the licensee or the staff of a retirement home provide to a resident of the home is the provision of a meal, the licensee shall ensure that,</p> <ul style="list-style-type: none"> <li>(a) if the licensee is the sole provider of the resident's meals, the resident is offered at least three meals per day at reasonable and regular meal hours, a beverage between the morning and midday meals, a snack and a beverage between the midday and evening meals and a snack and a beverage after the evening meal;</li> <li>(d) the menu cycle changes at least every 21 days;</li> <li>(e) the menu includes alternative entree choices at each meal;</li> <li>(g) the resident is informed of his or her daily and weekly menu options;</li> </ul>
<p><b>Inspection Finding</b></p> <p>Inspection confirmed that there was little to no snacks available to residents as stated on the menu, the menu cycle does not change at least every 21 days, the menu does not include alternative entree choices at each meal and residents are not informed of their daily and weekly menu options.</p>
<p><b>Outcome</b></p> <p>Corrective action taken by the Licensee.</p>
