

## FINAL INSPECTION REPORT Under the *Retirement Homes Act, 2010*

#### **Purpose of Inspection**

The RHRA received a report under section 75(1) of the *Retirement Homes Act, 2010* (the "RHA").

### NON-COMPLIANCE

### 1. The Licensee failed to comply with O. Reg. 166/11, s. 23; Behaviour management.

Specifically, the Licensee failed to comply with the following subsection(s):

**23. (1)** Every licensee of a retirement home shall develop and implement a written behaviour management strategy that includes,

(a) techniques to prevent and address resident behaviours that pose a risk to the resident or others in the home;

(b) strategies for interventions to prevent and address resident behaviours that pose a risk to the resident or others in the home;

(c) strategies for monitoring residents that have demonstrated behaviours that pose a risk to the resident or others in the home;

(d) protocols for how staff and volunteers shall report and be informed of resident behaviours that pose a risk to the resident or others in the home.

**23. (2)** The licensee shall ensure that all staff who provide care services to residents are advised at the beginning of every shift of each resident whose behaviours require heightened monitoring because those behaviours pose a risk to the resident or others in the home.

#### Inspection Finding

Staff identified that a resident was exhibiting responsive behaviors. The home's behavior management strategy notes to revise and document in the plan of care to include the responsive behavior identified, its trigger and strategies to prevent and manage the behavior. The home did not develop a plan of care for the resident. Staff did not implement the home's behavior management strategies.



### Outcome

Corrective action taken by the Licensee.

The Final Inspection Report is being provided to the Licensee, the Registrar of the Retirement Homes Regulatory Authority (the "RHRA") and the home's Residents' Council, if any.
