

# FINAL INSPECTION REPORT Under the Retirement Homes Act, 2010

## **Purpose of Inspection**

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

#### **NON-COMPLIANCE**

1. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Contents of plan.

Specifically, the Licensee failed to comply with the following subsection(s):

- <u>62. (4)</u> The licensee of a retirement home shall ensure that there is a written plan of care for each resident of the home that sets out,
  - (b) the planned care services for the resident that the licensee will provide, including,
    - (i) the details of the services,
    - (iii) clear directions to the licensee's staff who provide direct care to the resident;

## **Inspection Finding**

The Licensee did not ensure that the plan of care for at least two residents met the requirements listed.

# Outcome

Corrective action scheduled to be completed by the Licensee by December 11, 2015.

2. The Licensee failed to comply with O. Reg. 166/11, s. 17; Cleanliness.

Specifically, the Licensee failed to comply with the following subsection(s):

- **17. (1)** Every licensee of a retirement home shall ensure that the common areas of the home, including the floors and any furnishings, equipment and linens in those areas, are clean and sanitary.
- **17. (2)** Every licensee of a retirement home shall ensure that bathrooms in common areas of the home that are used by residents are adequately stocked with supplies including toilet paper.

17. (3) The licensee shall document the routines and methods used to comply with subsections (1) and (2).

## **Inspection Finding**

The Licensee did not ensure that all of the public bathrooms were kept clean and sanitary. Staff did not document the routines and methods used to keep the bathrooms clean and sanitary. Further, the Licensee did not ensure that bathrooms are adequately stocked with supplies.

#### **Outcome**

Corrective action scheduled to be completed by the Licensee by December 11, 2015.

## 3. The Licensee failed to comply with O. Reg. 166/11, s. 36; Continence care.

Specifically, the Licensee failed to comply with the following subsection(s):

- **36. (1)** If one of the care services that the licensee or the staff of a retirement home provide to a resident of the home is continence care, the licensee shall establish a continence care program that includes,
  - (a) measures to promote continence;
  - (b) measures to prevent constipation, including nutrition and hydration protocols;
  - (c) toileting programs;
  - (d) strategies to maximize the resident's independence, comfort and dignity, including the use of equipment, supplies, devices and assistive aids.

## **Inspection Finding**

Continence care is provided by the home. The Licensee did not establish a continence care program to meet the requirements listed in the Regulations and did not apply all of the requirements to one resident who is provided with continence care.

#### **Outcome**

Corrective action taken by the Licensee.
