Purpose of Inspection

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

NON-COMPLIANCE

1. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Reassessment and revision.

Specifically, the Licensee failed to comply with the following subsection(s):

62. (12) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time if, in the opinion of the licensee or the resident, (c) the care services set out in the plan have not been effective.

Inspection Finding

The Licensee reported to the Retirement Homes Regulatory Authority an incident involving resident to resident physical abuse. Inspection of the named residents' care files revealed the Licensee failed to ensure the residents' prescribed plans of care were updated as required. Specifically one plan of care was last demonstrated to be updated on January 2014 outside the prescribed six month limitation and one plan of care was not updated when care services identified in the plan of care were identified as not being effective.

Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.

2. The Licensee failed to comply with O. Reg. 166/11, s. 43; Initial assessment of care needs. The Licensee failed to comply with O. Reg. 166/11, s. 44; Full assessment of care needs. The Licensee failed to comply with O. Reg. 166/11, s. 55; Contents of records.

Specifically, the Licensee failed to comply with the following subsection(s):

- **43. (1)** Subject to section 45, no later than two days after a resident commences residency in a retirement home, the licensee of the home shall ensure that an initial assessment of the resident's immediate care needs is conducted.
- **44. (1)** Subject to section 46, no later than 14 days after a resident commences residency in a retirement home, the licensee shall ensure that a full assessment of the resident's care needs and preferences is conducted.
- 55. (2) The record for each resident shall include,
 - (b) if the resident was assessed for the purposes of developing the resident's plan of care, documentation of when the resident was assessed and by whom;

Inspection Finding

The Licensee reported to the Retirement Homes Regulatory Authority an incident involving resident to resident physical abuse. Inspection of the named residents' care files revealed the Licensee failed to keep prescribed records demonstrating that initial and full assessments of the aggressor's care needs had been completed as prescribed and within the prescribed time frames.

Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.
