Purpose of Inspection
The RHRA conducts routine inspections as set out in section 77(3) of the <i>Retirement Homes Act, 2010</i> (the "RHA").

NON-COMPLIANCE

<p>Inspection Finding</p> <p>During the inspection, the Licensee did not provide evidence of emergency testing of the loss of essential services.</p>
<p>Outcome</p> <p>The Licensee submitted plan to achieve compliance by April 14, 2017. RHRA to confirm compliance by inspection.</p>
<p>2. The Licensee failed to comply with O. Reg. 166/11, s. 59; Procedure for complaints to licensee.</p> <p>Specifically, the Licensee failed to comply with the following subsection(s):</p> <p>59. (2) The licensee shall ensure that a written record is kept in the retirement home that includes,</p>

(e) every date on which any response was provided to the complainant and a description of the response;

Inspection Finding

The complaints log provided at the inspection did not contain the date(s) the complainant was provided with a response.

Outcome

The Licensee submitted plan to achieve compliance by March 31, 2017. RHRA to confirm compliance by inspection.

3. The Licensee failed to comply with O. Reg. 166/11, s. 20; Food preparation.

Specifically, the Licensee failed to comply with the following subsection(s):

20. (4) The licensee shall ensure that whenever food is prepared in the retirement home, at least one person involved in preparing the food holds a current certificate in food handling from the local public health unit or has recently successfully completed a food handling training program equivalent to that offered by public health units.

Inspection Finding

The Licensee did not provide evidence that the preparation of food would always involve at least one individual who possesses valid certification in safe food handling.

Outcome


The Licensee submitted plan to achieve compliance by March 30, 2017. RHRA to confirm compliance by inspection.

The Final Inspection Report is being provided to the Licensee, the Registrar of the Retirement Homes Regulatory Authority (the "RHRA") and the home's Residents' Council, if any.
