Purpose of Inspection

The RHRA received a complaint under section 83(1) of the Retirement Homes Act, 2010 (the "RHA").

NON-COMPLIANCE

1. The Licensee failed to comply with O. Reg. 166/11, s. 47; Development of plan of care.

Specifically, the Licensee failed to comply with the following subsection(s):

- 47. (4) Subject to subsections (5) and (6), a plan of care for a resident is complete if the plan, (b) sets out,
 - (ii) the names and contact information of the resident's substitute decision-makers, if any,

Inspection Finding

The plan of care did not contain the names and contact information of the resident's substitute decision-makers. This lead to a failure to contact a resident's substitute decision maker in relation to an incident that had occurred when the Licensee's computer system was not functioning.

Outcome

The Licensee took corrective action to achieve compliance.

2. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 65; Training.

Specifically, the Licensee failed to comply with the following subsection(s):

65. (2) Every licensee of a retirement home shall ensure that no staff work in the home unless they have received training in,

- (b) the licensee's policy mentioned in subsection 67 (4) to promote zero tolerance of abuse and neglect of residents;
- (h) the emergency plan and the infection prevention and control program of the licensee for the home mentioned in subsection 60 (4);

Inspection Finding

A staff member employed by the home did not receive training in the Licensee's abuse policy and the emergency plan prior to working in the home.

Outcome

The Licensee took corrective action to achieve compliance.
