Purpose of Inspection

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

NON-COMPLIANCE

1. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 67; Protection against abuse and neglect.

Specifically, the Licensee failed to comply with the following subsection(s):

67. (1) Every licensee of a retirement home shall protect residents of the home from abuse by anyone.

Inspection Finding

Documents reviewed on the date of inspection revealed that a resident who was involved in a resident to resident physical abuse altercation causing injury on May 24, 2017, had been experiencing responsive behaviours affecting other residents since his admission to the home in the fall of 2016. The home failed to implement key aspects of their behaviour management policy including monitoring of the resident and referrals to outside agencies for assistance. Furthermore, the resident's plan of care was not updated to address any of the responsive behaviours detailing directions for staff on how to prevent and address the behaviours. Although the resident's physician had ordered medications PRN to assist with managing the resident's behaviours, the home had not administered any of these medications. In totality, this inaction caused a failure to protect the home's residents from abuse.

Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.

Specifically, the Licensee failed to comply with the following subsection(s):

65. (2) Every licensee of a retirement home shall ensure that no staff work in the home unless they have received training in,

<u>65. (4)</u> The licensee shall ensure that the persons who are required to receive the training described in subsection (2) receive on-going training as described in that subsection at the times required by the regulations.

Inspection Finding

On the date of the inspection, it was discovered that the home is not training staff at orientation and annually on their complete zero tolerance of abuse policy.

Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.
