

FINAL INSPECTION REPORT Under the Retirement Homes Act, 2010

Purpose of Inspection

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

NON-COMPLIANCE

1. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Contents of plan. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Documentation.

Specifically, the Licensee failed to comply with the following subsection(s):

- <u>62. (4)</u> The licensee of a retirement home shall ensure that there is a written plan of care for each resident of the home that sets out,
 - (b) the planned care services for the resident that the licensee will provide, including, (iii) clear directions to the licensee's staff who provide direct care to the resident;
- **62. (11)** The licensee shall ensure that the following are documented in accordance with the regulations, if any:
 - 1. The provision of the care services set out in the plan of care.

Inspection Finding

A resident's plan of care did not provide accurate directions to staff regarding her needs related to assistance with feeding and provision of a meal. Documentation of provision of care services was inconsistent.

Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.

2. The Licensee failed to comply with O. Reg. 166/11, s. 35; Assistance with bathing.

Specifically, the Licensee failed to comply with the following subsection(s):

- <u>35.</u> If one of the care services that the licensee or the staff of a retirement home provide to a resident of the home is assistance with bathing, the licensee shall ensure that,
 - (c) the resident is bathed as frequently as is consistent with the resident's plan of care.

Inspection Finding

A resident was not bathed as frequently as detailed in her plan of care.

Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.

3. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 64; Police background checks. The Licensee failed to comply with O. Reg. 166/11, s. 13; Hiring staff and volunteers.

Specifically, the Licensee failed to comply with the following subsection(s):

- **64. (2)** The screening measures shall include a police background check as defined in the regulations, unless the person being screened is under 18 years of age.
- **13. (1)** The police background check required by section 64 of the Act for a staff member or a volunteer working in a retirement home shall be,
 - (a) conducted by a police force;
- **13. (2)** The police background check shall include a vulnerable sector screen to determine the person's suitability to be a staff member or volunteer in a retirement home and to protect residents from abuse and neglect.

Inspection Finding

A staff member did not have the required screening.

Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.
