## **Purpose of Inspection**

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

## **NON-COMPLIANCE**

The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Involvement of resident, etc..
The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Assessment of resident.
The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Persons who approve plans of care.

Specifically, the Licensee failed to comply with the following subsection(s):

- <u>62. (5)</u> The licensee shall ensure that the resident, the resident's substitute decision-maker, if any, and any other persons designated by the resident or substitute decision-maker are given an opportunity to participate in the development, implementation and reviews of the resident's plan of care.
- <u>62. (6)</u> The licensee shall ensure that the plan of care is based on an assessment of the resident and the needs and preferences of the resident.
- **62. (9)** The licensee shall ensure that the following persons have approved the plan of care, including any revisions to it, and that a copy is provided to them:
  - 2. The prescribed person if there is a person prescribed for the purpose of this paragraph.

## **Inspection Finding**

The Licensee provided no evidence that the resident or the resident's substitute decision maker participated in the development of the residents plan of care. Further, the Licensee provided no evidence of the person who approved the plan of care. Furthermore, the plan of care was not based on an assessment of the resident's needs and preferences.

#### **Outcome**

The Licensee submitted a plan to achieve compliance by November 01, 2017. RHRA to confirm compliance by inspection.

# 2. The Licensee failed to comply with O. Reg. 166/11, s. 22; Risk of falls.

Specifically, the Licensee failed to comply with the following subsection(s):

**22. (3)** If a resident of a retirement home falls in the home in circumstances other than those described in subsection (2) and the licensee or a staff member becomes aware of the fall, the licensee shall ensure that the licensee or a staff member documents the fall, the response to the fall and the corrective actions taken, if any.

# **Inspection Finding**

The Licensee failed to take any corrective action of a residents repeated falls.

## **Outcome**

The Licensee submitted a plan to achieve compliance by September 29, 2017. RHRA to confirm compliance by inspection.
