Purpose of Inspection
The RHRA received a report under section 75(1) of the <i>Retirement Homes Act, 2010</i> (the "RHA").

NON-COMPLIANCE

(9) The licensee shall ensure that the following persons have approved the plan of care, including any revisions to it, and that a copy is provided to them:</p> <p style="padding-left: 40px;">1. The resident or the resident's substitute decision-maker.</p> <p>62. (12) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time if, in the opinion of the licensee or the resident,</p> <p style="padding-left: 40px;">(c) the care services set out in the plan have not been effective.</p>

Inspection Finding

A resident of the home was hospitalized following an incident in September and there was a later incident of elopement on October 28. However, the resident's plan of care was not reassessed and revised to reflect how the resident's behaviours were going to be managed. Although the plan of care for a resident was revised on September 7 and again on November 13, 2017 the resident's substitute decision-maker had not approved the changes, as prescribed. Although the resident/ substitute decision-maker gave consent for the collection and use of information regarding the external care provider, the details and the goals of the services were not included in the plan of care.

Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.

The Final Inspection Report is being provided to the Licensee, the Registrar of the Retirement Homes Regulatory Authority (the "RHRA") and the home's Residents' Council, if any.
