Purpose of Inspection

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

NON-COMPLIANCE The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 65; Training. 1. The Licensee failed to comply with O. Reg. 166/11, s. 14; Staff training. The Licensee failed to comply with O. Reg. 166/11, s. 35; Assistance with bathing. Specifically, the Licensee failed to comply with the following subsection(s): 65. (2) Every licensee of a retirement home shall ensure that no staff work in the home unless they have received training in, (i) all Acts, regulations, policies of the Authority and similar documents, including policies of the licensee, that are relevant to the person's duties; 14. (3) For the purposes of paragraph 5 of subsection 65 (5) of the Act, every licensee of a retirement home shall ensure that every staff member who provides a care service to a resident has received or receives training in, (b) each care service offered in the home so that the staff member is able to understand the general nature of each of those services, the standards applicable under the Act to each of those services and the aspects of each of those services that may be relevant to the staff member's own duties in the home. 35. If one of the care services that the licensee or the staff of a retirement home provide to a resident of the home is assistance with bathing, the licensee shall ensure that, (a) the resident is bathed only by staff who are trained to bathe a person of the resident's characteristics and condition; Inspection Finding Training records reviewed at the inspection, indicated that one staff member who provided training to a resident, was not trained in the Licensee's procedures on bathing residents. Outcome The Licensee took corrective action to achieve compliance.
