# **Purpose of Inspection**

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

## **NON-COMPLIANCE**

1. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 67; Policy to promote zero tolerance.

Specifically, the Licensee failed to comply with the following subsection(s):

<u>67. (4)</u> Without in any way restricting the generality of the duties described in subsections (1) and (2), the licensee shall ensure that there is a written policy to promote zero tolerance of abuse and neglect of residents and shall ensure that the policy is complied with.

## **Inspection Finding**

The Licensee received an allegation of a criminal nature which involved possible injuries. Contrary to their policy on zero tolerance on resident abuse, the Licensee failed to immediately notify the police and seek medical attention for the resident.

#### Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.

2. The Licensee failed to comply with O. Reg. 166/11, s. 22; Risk of falls.

Specifically, the Licensee failed to comply with the following subsection(s):

**22. (1)** Every licensee of a retirement home shall develop, document and implement strategies to reduce or mitigate the risk of falls in common areas of the home.

# **Inspection Finding**

The evidence indicated that although the resident suffered several falls, there was no implementation of the Licensee's stipulation that the resident's risk of falls and appropriate interventions were discussed with members of a multi-disciplinary team including a physician and physio-therapist.

### Outcome

The Licensee submitted plan to achieve compliance by September 12, 2018. RHRA to confirm compliance by inspection.
