# **Purpose of Inspection**

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

## **NON-COMPLIANCE**

1. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 67; Policy to promote zero tolerance.

Specifically, the Licensee failed to comply with the following subsection(s):

<u>67. (4)</u> Without in any way restricting the generality of the duties described in subsections (1) and (2), the licensee shall ensure that there is a written policy to promote zero tolerance of abuse and neglect of residents and shall ensure that the policy is complied with.

## **Inspection Finding**

The home reported 1 incident of abuse by resident; however, evidence obtained during the inspection revealed that the home failed to fully comply with their zero-abuse policy in addressing previous incidents involving the same residents. Specifically relating to mandatory reporting requirements and incident investigation / analysis as per the legislative requirements.

#### **Outcome**

The Licensee submitted a plan to achieve compliance by November 30, 2018. RHRA to confirm compliance by inspection.

2. The Licensee failed to comply with O. Reg. 166/11, s. 23; Behaviour management.

Specifically, the Licensee failed to comply with the following subsection(s):

**23. (1)** Every licensee of a retirement home shall develop and implement a written behaviour management strategy that includes,

- (a) techniques to prevent and address resident behaviours that pose a risk to the resident or others in the home;
- (b) strategies for interventions to prevent and address resident behaviours that pose a risk to the resident or others in the home;
- (c) strategies for monitoring residents that have demonstrated behaviours that pose a risk to the resident or others in the home;

# **Inspection Finding**

The behavior management strategy reviewed at the time of the inspection appeared to be a template and had not been developed for the home. The home failed to implement a behavior management strategy for a resident exhibiting responsive behaviours. Specifically, the home failed to update the resident's plan of care with the behaviours and monitoring requirements as per the reviewed strategy and there was no evidence to support that the home had implemented any techniques and strategies to prevent and address resident behaviours or that the resident was monitored following an incident of a responsive behavior.

## **Outcome**

The Licensee submitted a plan to achieve compliance by November 30, 2018. RHRA to confirm compliance by inspection.
