Purpose of Inspection

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

NON-COMPLIANCE

1. The Licensee failed to comply with O. Reg. 166/11, s. 22; Risk of falls.

Specifically, the Licensee failed to comply with the following subsection(s):

22. (1) Every licensee of a retirement home shall develop, document and implement strategies to reduce or mitigate the risk of falls in common areas of the home.

Inspection Finding

The evidence shows the home is not fully implementing the directives of their Falls Prevention Policy; specifically, not all residents are being screened for risk of falls, resident's falls risks and changes in resident's falls risks are not all being documented in their plans of care, and the home is not consistently documenting identified strategies and interventions to mitigate or minimize falls in resident's plans of care.

Outcome

The Licensee submitted plan to achieve compliance by April 1, 2019. RHRA to confirm compliance by inspection.

Specifically, the Licensee failed to comply with the following subsection(s):

- <u>62. (4)</u> The licensee of a retirement home shall ensure that there is a written plan of care for each resident of the home that sets out,
 - (b) the planned care services for the resident that the licensee will provide, including,
 - (i) the details of the services,
 - (iii) clear directions to the licensee's staff who provide direct care to the resident;
- <u>62. (5)</u> The licensee shall ensure that the resident, the resident's substitute decision-maker, if any, and any other persons designated by the resident or substitute decision-maker are given an opportunity to participate in the development, implementation and reviews of the resident's plan of care.
- **62. (9)** The licensee shall ensure that the following persons have approved the plan of care, including any revisions to it, and that a copy is provided to them:
 - 1. The resident or the resident's substitute decision-maker.
- **62. (12)** The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time if, in the opinion of the licensee or the resident,
 - (b) the resident's care needs change or the care services set out in the plan are no longer necessary;

Inspection Finding

The home failed to ensure that all the reviewed resident plans of care have been revised at least every six months or at any time the resident's care needs have changed, and not all of those plans of care were either initially approved by the resident or their substitute decision-maker or when changes or revisions were made to a plan of care. Further, there was no evidence to support that all the residents or their substitute decision-makers were given an opportunity to participate in the development or reviews of their plans of care, and not all the plans of care reviewed included details of the care services and clear directions to the staff providing care to the residents.

Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.
