Purpose of Inspection

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

NON-COMPLIANCE

1. The Licensee failed to comply with O. Reg. 166/11, s. 40; Provision of a meal.

Specifically, the Licensee failed to comply with the following subsection(s):

- <u>40.</u> If one of the care services that the licensee or the staff of a retirement home provide to a resident of the home is the provision of a meal, the licensee shall ensure that,
 - (g) the resident is informed of his or her daily and weekly menu options;

Inspection Finding

At the time of the inspection the evidence showed that the residents were not informed of their weekly menu choices, as prescribed.

Outcome

The Licensee submitted a plan to achieve compliance by February 20, 2020. RHRA to confirm compliance by inspection.

2. The Licensee failed to comply with O. Reg. 166/11, s. 18; Pest control.

Specifically, the Licensee failed to comply with the following subsection(s):

18. (3) The licensee shall ensure that timely action is taken to deal with pests in the retirement home.

Inspection Finding

The Licensee received a report from the pest-controller on January 24, 2020 of bedbugs in the dining room chairs but there was no evidence that timely action was taken to deal with the pests.

Outcome

The Licensee submitted a plan to achieve compliance by March 26, 2020. RHRA to confirm compliance by inspection.

3. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 65; Training.

Specifically, the Licensee failed to comply with the following subsection(s):

- **65. (2)** Every licensee of a retirement home shall ensure that no staff work in the home unless they have received training in,
 - (i) all Acts, regulations, policies of the Authority and similar documents, including policies of the licensee, that are relevant to the person's duties;

Inspection Finding

At the time of inspection, the Licensee was not able to provide evidence to confirm that staff of the Home had received training in the Home's bedbug protocol.

Outcome

The Licensee submitted a plan to achieve compliance by February 21, 2020. RHRA to confirm compliance by inspection.
