Purpose of Inspection
The RHRA received a report under section 75(1) of the <i>Retirement Homes Act, 2010</i> (the "RHA").

NON-COMPLIANCE
<p>1. The Licensee failed to comply with O. Reg. 166/11, s. 27; Infection prevention and control program.</p> <p>Specifically, the Licensee failed to comply with the following subsection(s):</p> <p>27. (5) The licensee of a retirement home shall ensure that,</p> <p>(0.b) all reasonable steps are taken in the retirement home to follow,</p> <p>(i) any directive respecting coronavirus (COVID-19) issued to long-term care homes by the Chief Medical Officer of Health under section 77.7 of the Health Protection and Promotion Act,</p> <p>(ii) any guidance, advice or recommendations respecting coronavirus (COVID-19) that are given to long-term care homes by the Chief Medical Officer of Health and made available on the Government of Ontario's website respecting coronavirus (COVID-19);</p>
<p>Inspection Finding</p> <p>The Licensee failed to ensure that all reasonable steps are taken by the retirement home to follow the directives respecting coronavirus (COVID-19) issued the Chief Medical Officer of Health as well as the recommendations given to retirement homes by the Chief Medical Officer of Health, with regards to ensuring residents maintain 2 meters physical distancing in all common areas.</p>
<p>Outcome</p> <p>At the time of the inspection, the Licensee was not in compliance. The licensee has since taken corrective action to achieve compliance.</p>
