### **Purpose of Inspection**

The RHRA conducts routine inspections as set out in section 77(3) of the *Retirement Homes Act, 2010* (the "RHA").

#### **NON-COMPLIANCE**

The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Contents of plan.
The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Persons who approve plans of care.

Specifically, the Licensee failed to comply with the following subsection(s):

- <u>62. (4)</u> The licensee of a retirement home shall ensure that there is a written plan of care for each resident of the home that sets out,
  - (b) the planned care services for the resident that the licensee will provide, including,(iii) clear directions to the licensee's staff who provide direct care to the resident;
- **62. (9)** The licensee shall ensure that the following persons have approved the plan of care, including any revisions to it, and that a copy is provided to them:
  - 1. The resident or the resident's substitute decision-maker.

# **Inspection Finding**

The four (4) plans of care reviewed did not include clear direction to the staff on fall prevention and behaviour strategies. Furthermore there were no plans of care approvals found during inspection.

#### **Outcome**

The Licensee submitted a plan to achieve compliance by October 1, 2021. RHRA to confirm compliance by inspection.

# 2. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 65; On-going training.

Specifically, the Licensee failed to comply with the following subsection(s):

<u>65. (4)</u> The licensee shall ensure that the persons who are required to receive the training described in subsection (2) receive on-going training as described in that subsection at the times required by the regulations.

#### **Inspection Finding**

The home was not able to provide clear evidence that staff received annual training as required.

#### **Outcome**

The Licensee submitted a plan to achieve compliance by September 13, 2021. RHRA to confirm compliance by inspection.

# 3. The Licensee failed to comply with O. Reg. 166/11, s. 17; Cleanliness.

Specifically, the Licensee failed to comply with the following subsection(s):

**17. (3)** The licensee shall document the routines and methods used to comply with subsections (1) and (2).

## **Inspection Finding**

There was no evidence indicating that the home documents the routines and methods of cleaning and disinfecting.

# Outcome

The Licensee submitted a plan to achieve compliance by September 13, 2021. RHRA to confirm compliance by inspection.
