### **Purpose of Inspection**

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

# **NON-COMPLIANCE**

1. The Licensee failed to comply with O. Reg. 166/11, s. 27; Infection prevention and control program.

Specifically, the Licensee failed to comply with the following subsection(s):

**27.** (5) The licensee of a retirement home shall ensure that,

(0.a) any guidance, advice or recommendations given to retirement homes by the Chief Medical Officer of Health are followed in the retirement home;

# **Inspection Finding**

The Licensee failed to ensure that the guidance, advice or recommendations given to retirement homes by the Chief Medical Officer of Health are followed in the retirement home by failing to do proper screening on entry to the home.

#### **Outcome**

The Licensee must take corrective action to achieve compliance

2. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 67; Protection against abuse and neglect.

Specifically, the Licensee failed to comply with the following subsection(s):

67. (1) Every licensee of a retirement home shall protect residents of the home from abuse by anyone.

#### **Inspection Finding**

The Licensee failed to protect the resident from abuse by forcefully washing the resident outside the home
