# **Purpose of Inspection**

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

# NON-COMPLIANCE

1. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 75; Reporting certain matters to Registrar.

Specifically, the Licensee failed to comply with the following subsection(s):

**75. (1)** A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Registrar:

2. Abuse of a resident by anyone or neglect of a resident by the licensee or the staff of the retirement home of the resident if it results in harm or a risk of harm to the resident.

### Inspection Finding

An incident of resident-to-resident physical abuse was reported to the RHRA by the local police service which resulted in an inspection of the incident. The evidence collected during the inspection revealed that the Licensee had reasonable grounds to suspect that a resident-to-resident abuse had occurred repeatedly between the same residents, resulting in harm or risk of harm and failed to report the incidents to the registrar as required.

### Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.

# 2. The Licensee failed to comply with O. Reg. 166/11, s. 23; Behaviour management.

Specifically, the Licensee failed to comply with the following subsection(s):



**<u>23. (1)</u>** Every licensee of a retirement home shall develop and implement a written behaviour management strategy that includes,

(a) techniques to prevent and address resident behaviours that pose a risk to the resident or others in the home;

(b) strategies for interventions to prevent and address resident behaviours that pose a risk to the resident or others in the home;

## **Inspection Finding**

In review of the collected evidence during the inspection mentioned above, the Licensee failed to ensure that a written behavior management strategy was developed and implemented, which included techniques and interventions to prevent and address resident behaviors that pose a risk to others in the home.

## Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.

3. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 67; Protection against abuse and neglect.

Specifically, the Licensee failed to comply with the following subsection(s):

**<u>67. (1)</u>** Every licensee of a retirement home shall protect residents of the home from abuse by anyone.

### **Inspection Finding**

The evidence collected during the above mentioned inspection revealed that the Licensee had knowledge of a history of aggression resulting in harm between two residents and failed to implement measures to protect the victim from further abuse.

### Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by inspection.
