Purpose of Inspection
The RHRA received a report under section 75(1) of the <i>Retirement Homes Act, 2010</i> (the "RHA").

NON-COMPLIANCE

Inspection Finding

The RHRA conducted an inspection in response to an allegation of abuse involving a staff member and resident. The Inspector reviewed the residents' plan of care and noted the plan lacked clear direction for staff when providing assistance with ambulation. Further, there was no evidence that neither the resident or their substitute decision maker was involved in the development on reviews and revisions to the plan nor had they approved the revisions. The resident care needs had changed, and these needs were not included in the plan of care. The Licensee failed to complete a plan of care as prescribed.

Outcome


The Licensee submitted a plan to achieve compliance by August 31, 2022. RHRA to confirm compliance by following up with the Licensee or by inspection.

The Final Inspection Report is being provided to the Licensee, the Registrar of the Retirement Homes Regulatory Authority (the "RHRA") and the home's Residents' Council, if any.
