

# FINAL INSPECTION REPORT Under the Retirement Homes Act, 2010

#### **Purpose of Inspection**

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

#### **NON-COMPLIANCE**

1. The Licensee failed to comply with O. Reg. 166/11, s. 40; Provision of a meal.

Specifically, the Licensee failed to comply with the following subsection(s):

- <u>40.</u> If one of the care services that the licensee or the staff of a retirement home provide to a resident of the home is the provision of a meal, the licensee shall ensure that,
  - (i) food service workers and staff assisting the resident are aware of the resident's diet, special needs and preferences;

#### **Inspection Finding**

The RHRA received a report that a resident had been served food that was on her restricted list. The inspector reviewed the resident's file and documentation on diet restrictions. It was found that the Licensee did not ensure staff was made aware of the resident's diet.

### Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by following up with the Licensee or by inspection.

2. The Licensee failed to comply with O. Reg. 166/11, s. 19; Maintenance.

Specifically, the Licensee failed to comply with the following subsection(s):

**19. (1)** Every licensee of a retirement home shall ensure that a maintenance program is in place to ensure that the building forming the retirement home, including both interior and exterior areas and its operational systems, are maintained in good repair.

- **19. (2)** The maintenance program shall include policies and procedures for routine, preventative and remedial maintenance of the following in the retirement home:
  - 3. If provided by the licensee, ventilation systems, air conditioning systems, hot water holding tanks and computerized systems monitoring the home's water temperature.

#### **Inspection Finding**

The inspector viewed and photographed an air conditioning unit that presented signs of moisture on the surrounding encasement. Evidence indicated that the unit had not received the required preventative maintenance.

#### **Outcome**

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by following up with the Licensee or by inspection.

3. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Assessment of resident.

Specifically, the Licensee failed to comply with the following subsection(s):

<u>62. (6)</u> The licensee shall ensure that the plan of care is based on an assessment of the resident and the needs and preferences of the resident.

#### **Inspection Finding**

The inspector reviewed resident documents and interviewed relevant personnel. Documentation showed that the resident's current plan of care did not contain all information from the resident's most recently completed assessment. The Licensee did not ensure that the resident's plan of care reflected the current needs.

### **Outcome**

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by following up with the Licensee or by inspection.
