Purpose of Inspection

The RHRA conducts compliance inspections as set out in section 77(1) of the *Retirement Homes Act, 2010* (the "RHA").

NON-COMPLIANCE

1. The Licensee failed to comply with O. Reg. 166/11, s. 27; Infection prevention and control program.

Specifically, the Licensee failed to comply with the following subsection(s):

27. (5) The licensee of a retirement home shall ensure that,

(0.a) any guidance, advice or recommendations given to retirement homes by the Chief Medical Officer of Health are followed in the retirement home.

Inspection Finding

A report was made to the RHRA regarding concerns of the Licensee's management of an COVID-19 outbreak at the home. As part of the inspection, the Inspector interviewed a volunteer working in the home and made observations, and found that the Licensee failed to follow the Chief Medical Officer of Health and the Ministry of Health's recommendations outlined in the updated COVID-19 Guidance. Specifically, there was no outside signage on the home's door advising visitors the home is in outbreak, lack of active screening, inconsistent use of proper PPE by the volunteer, lack of cohorting of residents, no IPAC training including knowledge of proper donning and doffing of PPE, not using a health care grade cleaner/disinfectant in the home, and no evidence that resident temperature and signs and symptoms checks were completed twice daily as required during an outbreak.

Outcome

The Licensee must take corrective action to achieve compliance.
