

# FINAL INSPECTION REPORT Under the *Retirement Homes Act, 2010*

**Purpose of Inspection** 

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

### **NON-COMPLIANCE**

1. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Performance of assessments, etc..

The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Contents of plan. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Persons who approve plans of care.

The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 62; Reassessment and revision. The Licensee failed to comply with O. Reg. 166/11, s. 44; Full assessment of care needs.

Specifically, the Licensee failed to comply with the following subsection(s):

**62. (3)** All assessments and reassessments mentioned in this section that a licensee performs shall be performed in accordance with the prescribed criteria.

**62. (4)** The licensee of a retirement home shall ensure that there is a written plan of care for each resident of the home that sets out,

- (b) the planned care services for the resident that the licensee will provide, including,
  - (ii) the goals that the services are intended to achieve.

**62. (9)** The licensee shall ensure that the following persons have approved the plan of care, including any revisions to it, and that a copy is provided to them:

1. The resident or the resident's substitute decision-maker.

2. The prescribed person if there is a person prescribed for the purpose of this paragraph.

<u>62. (12)</u> The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months.

**<u>44. (2)</u>** The full assessment mentioned in subsection (1) shall consider the following matters with respect to the resident:

7. The matters listed in subsection 43 (2).

#### **Inspection Finding**

A report was made to the RHRA about a matter that could not be confirmed. As part of the inspection, the inspector reviewed several records including a resident's assessment and plan of care. The related documentation did not fully address assessment and plan of care provisions related to assessments, the inclusion of goals, required approvals, reassessments, and the review and revision of the plan of care. The Licensee failed to ensure the listed assessment and plan of care requirements had been fully met.

#### Outcome

The Licensee submitted a plan to achieve compliance by December 29, 2022. RHRA to confirm compliance by following up with the Licensee or by inspection.

### 2. The Licensee failed to comply with O. Reg. 166/11, s. 27; Infection prevention and control program.

Specifically, the Licensee failed to comply with the following subsection(s):

**<u>27. (5)</u>** The licensee of a retirement home shall ensure that,

(0.a) any guidance, advice or recommendations given to retirement homes by the Chief Medical Officer of Health are followed in the retirement home.

### **Inspection Finding**

On the day of inspection, a staff member was observed in the kitchen area of the home without a mask. The staff member went on to meet the inspector within the home without a mask. The Licensee failed to ensure compliance with guidance provided by the Chief Medical Officer of Health.

#### Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by following up with the Licensee or by inspection.

The Final Inspection Report is being provided to the Licensee, the Registrar of the Retirement Homes Regulatory Authority (the "RHRA") and the home's Residents' Council, if any.
