About Responsive Inspections

A responsive inspection, performed by an RHRA inspector, is a physical inspection of a licensed retirement home. A responsive inspection is conducted when RHRA receives information that the licensee may have failed to meet the standards of the *Retirement Homes Act, 2010* or its regulations (the "*RHA*"). An inspection being conducted does not infer that an allegation is substantiated or that a contravention of the RHA has occurred. A licensee is required to report to RHRA if they suspect harm or risk of harm to a resident. During a responsive inspection, an RHRA inspector may observe the operations of the home, interview relevant individuals, review records and other documentation, and determine whether the licensee's management and staff have followed mandatory policies and practices designed to protect the welfare of residents.

Following a responsive inspection, the RHRA inspector prepares a draft inspection report which is sent to the licensee. The draft report may include instances where the licensee has failed to meet the standards of the RHA. If included, the licensee can respond to these instances and is strongly encouraged to inform RHRA of its plans to meet the standards of the RHA.

Following the draft report, the RHRA inspector prepares this final inspection report, incorporating any response from the licensee with their plans to meet the standards of the RHA. The most recent final inspection report must be posted in the home in a visible and easily accessible location. All final inspection reports from the previous two years must also be made available in an easily accessible location in the home. The licensee must provide a copy of this report to the home's Residents' Council, if one exists.

In addition to inspection reports, RHRA may provide information to a licensee to encourage improvements of their current practices.

If there is a serious incident or the licensee repeatedly does not meet the required standards, RHRA may take further action.

Concern(s)

During a responsive inspection, an inspector will focus primarily on the concern(s) which prompted the inspection and may take various actions to determine whether the licensee is compliant with the RHA in relating to the concern(s). Any findings of non-compliance identified in relation to these concerns are listed below.

Concern #1: CON-5183-Staff Training

RHRA Inspector Findings

The Inspector followed up on areas of previous non-compliance relating to new staff training. The Inspector reviewed training records and interviewed staff and again found several areas of noncompliance, as the majority of new staff had not completed training in the required areas of Zero Tolerance of Abuse, Bill of Rights, Infection control, Whistle Blower protection, PASDs, Fire prevention and safety, and Complaints, prior to working in the home. The Licensee failed to ensure that staff were trained as required.

Outcome

The Licensee submitted a plan to achieve compliance by Wed June 21, 2023. RHRA to confirm compliance by following up with the Licensee or by inspection.

Concern #2: CON-5185-Emergency Plan

RHRA Inspector Findings

The Inspector followed up on areas of previous non-compliance relating to emergency plans. The Inspector reviewed the home's emergency plan and interviewed staff and found the Licensee failed to ensure there were adequate arrangements in place with community partners involved in responding to emergencies at the home.

Outcome

The Licensee submitted a plan to achieve compliance by Wed June 21, 2023. RHRA to confirm compliance by following up with the Licensee or by inspection.

Concern #3: CON-5187-Assessments and Plans of Care

RHRA Inspector Findings

The Inspector followed up on areas of previous non-compliance relating to resident's plans of care. The Inspector reviewed resident care files and interviewed staff and again found several areas of non-compliance. Firstly, the majority of the plans of care were not approved by the residents or their substitute decisionmakers, and by a member of the College of Physicians and Surgeons of Ontario or the College of Nurses of Ontario or someone working under their supervision. Secondly, there were no documented details or clear directions to staff regarding the provision of meals for

the majority of the plans of care reviewed. Lastly, for those reviewed residents who are at risk for falls, their falls risk and their individual needs relating to their falls risk were not documented in their respective plans of care. The Licensee failed to ensure that residents' plans of care were compliant in the noted areas.

Outcome

The Licensee submitted a plan to achieve compliance by Wed June 21, 2023. RHRA to confirm compliance by following up with the Licensee or by inspection.

Additional Findings

During a responsive inspection, an inspector may observe areas of non-compliance that are not related to the concern(s) which prompted the inspection. In these cases, an inspector may cite the home for these contraventions at the time of this inspection. In addition, an inspector may follow-up on findings of non-compliance from previous inspections. Where the licensee is unable to demonstrate they have come into compliance or maintained compliance, an inspector may cite the home for these repeat contraventions at the time of this inspection.
