About Responsive Inspections

A responsive inspection, performed by an RHRA inspector, is a physical inspection of a licensed retirement home. A responsive inspection is conducted when RHRA receives information that the licensee may have failed to meet the standards of the *Retirement Homes Act, 2010* or its regulations (the “RHA”). An inspection being conducted does not infer that an allegation is substantiated or that a contravention of the RHA has occurred. A licensee is required to report to RHRA if they suspect harm or risk of harm to a resident. During a responsive inspection, an RHRA inspector may observe the operations of the home, interview relevant individuals, review records and other documentation, and determine whether the licensee’s management and staff have followed mandatory policies and practices designed to protect the welfare of residents.

Following a responsive inspection, the RHRA inspector prepares a draft inspection report which is sent to the licensee. The draft report may include instances where the licensee has failed to meet the standards of the *RHA*. If included, the licensee can respond to these instances and is strongly encouraged to inform RHRA of its plans to meet the standards of the *RHA*.

Following the draft report, the RHRA inspector prepares this final inspection report, incorporating any response from the licensee with their plans to meet the standards of the *RHA*. The most recent final inspection report must be posted in the home in a visible and easily accessible location. All final inspection reports from the previous two years must also be made available in an easily accessible location in the home. The licensee must provide a copy of this report to the home’s Residents’ Council, if one exists.

In addition to inspection reports, RHRA may provide information to a licensee to encourage improvements of their current practices.

If there is a serious incident or the licensee repeatedly does not meet the required standards, RHRA may take further action.

Concern(s)

During a responsive inspection, an inspector will focus primarily on the concern(s) which prompted the inspection and may take various actions to determine whether the licensee is compliant with the RHA in relating to the concern(s). Any findings of non-compliance identified in relation to these concerns are listed below.

Concern #1: CON-5348-Infection Prevention and Control

RHRA Inspector Findings

Upon arrival at the home, it was noted that 2 of the staff in the home were not wearing medical masks as required. Additionally, the Licensee failed to ensure that staff received training annually regarding the need for and method of maintaining proper hand hygiene and method of preventing cross contamination, and the need for and process of reporting, providing surveillance of and documenting incidents of infectious illness. The Licensee failed to ensure that staff receive the required training annually.

Outcome

The Licensee must take corrective action to achieve compliance.

Concern #2: CON-5349-Assessments and Plans of Care

RHRA Inspector Findings

The inspector reviewed five resident care files and found that the Licensee had not reviewed or revised any assessments and plans of care since October 15, 2022. The plans of care for two residents did not address personal hygiene, toileting and dressing services, which the residents were receiving, with details, goals or clear directions to staff, as required. Additionally, the Licensee was unable to produce evidence that an assessment and plan of care had been completed for one resident. The Licensee failed to ensure that assessments and plans of care reviewed and revised as required.

Outcome

The Licensee must take corrective action to achieve compliance.

Concern #3: CON-5350-Medication Management

RHRA Inspector Findings

The inspector reviewed the Medication Administration Record for all residents and found that for one resident the Licensee was not administering the medication as ordered by the physician. The Licensee was unable to produce evidence of having written prescriptions on file for the medications being administered. Additionally, the Licensee failed to ensure that the person administering

medications signs the medication administration record as required. The Licensee failed to ensure that the person administering the drug or other substance prepares a written record noting the time and date on which it was administered and failed to ensure that no drug is administered by the licensee or the staff to the resident in the home except in accordance with the directions for use specified by the person who prescribed the drug for the resident.

Outcome

The Licensee must take corrective action to achieve compliance.

Concern #4: CON-5351-Emergency Planning

RHRA Inspector Findings

The inspector reviewed the Emergency Plan documentation and found that the Licensee had not completed any of the required emergency code testing, including the loss of essential services, situations involving a missing resident, medical emergency or violent outbursts. The Licensee failed to ensure that on an annual basis at least, test the emergency plan, including arrangements with community agencies, partner facilities and resources that will be involved in responding to an emergency.

Outcome

The Licensee must take corrective action to achieve compliance.

Additional Findings

During a responsive inspection, an inspector may observe areas of non-compliance that are not related to the concern(s) which prompted the inspection. In these cases, an inspector may cite the home for these contraventions at the time of this inspection. In addition, an inspector may follow-up on findings of non-compliance from previous inspections. Where the licensee is unable to demonstrate they have come into compliance or maintained compliance, an inspector may cite the home for these repeat contraventions at the time of this inspection.
