About Routine Inspections
<p>A routine inspection, performed by an RHRA inspector, is a physical inspection of a licensed retirement home. During a routine inspection, an RHRA inspector will walk through the home, speak to residents and staff, observe care services and conditions in the home, and ensure the licensee's management and staff follow mandatory policies and practices designed to protect the welfare of residents.</p> <p>Following a routine inspection, the RHRA inspector prepares a draft inspection report which is sent to the licensee. The draft report may include instances where the licensee has failed to meet the standards of the <i>RHA</i>. If included, the licensee can respond to these instances and is strongly encouraged to inform RHRA of its plans to meet the standards of the <i>RHA</i>.</p> <p>Following the draft report, the RHRA inspector prepares this final inspection report, incorporating any response from the licensee with their plans to meet the standards of the <i>RHA</i>. The most recent final inspection report must be posted in the home in a visible and easily accessible location. All final inspection reports from the previous two years must also be made available in an easily accessible location in the home. The licensee must provide a copy of this report to the home's Residents' Council, if one exists.</p> <p>In addition to inspection reports, RHRA may provide information to a licensee to encourage improvements of their current practices.</p> <p>If the licensee repeatedly does not meet the required standards, RHRA may take further action.</p>

Focus Areas
<p><i>During a routine inspection, an inspector will focus primarily on a set number of areas which have been identified as related to the health, safety and wellbeing of resident, and may take various actions to determine whether the licensee is compliant with the RHA in relating to the areas. The areas listed in this section are ones which an inspector has identified as non-compliant.</i></p>
Focus Area #1: Emergency Plan
<p>RHRA Inspector Findings</p> <p>As part of the routine inspection, the Inspector interviewed staff and reviewed the Licensee's records of testing for their Emergency Plans and found that the home completed the required testing for the majority of codes but was unable to demonstrate that testing for missing residents was completed. The Licensee failed to ensure that all required testing was done annually.</p>
<p>Outcome</p> <p>The Licensee submitted a plan to achieve compliance by Thursday August 31, 2023. RHRA to confirm compliance by following up with the Licensee or by inspection.</p>
Focus Area #2: Resident Record, Assessment, Plan of Care

RHRA Inspector Findings

The Inspector reviewed a sample of resident care files and interviewed staff and found several areas of non-compliance. Firstly, initial plans of care had not been completed for two new residents and assessments and plans of care had not been completed for the six respite residents in the home. Secondly, a resident's plan of care had not been reviewed and revised every six months as required. Thirdly, half of the reviewed plans of care were not approved by a member of the College of Physicians and Surgeons of Ontario or the College of Nurses of Ontario or someone working under their supervision and there was no evidence that a plan of care had been approved by the resident or their substitute decision-maker. Lastly, a resident's needs related to their risk of falls was not documented in their plan of care. The Licensee failed to ensure that all resident plans of care reviewed were compliant in the noted areas.

Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by following up with the Licensee or by inspection.

Focus Area #3: Staff Training**RHRA Inspector Findings**

The Inspector reviewed a sample of staff training records and found that not all new staff completed the required training prior to working in the home or at all and that not all existing staff reviewed completed training on an annual basis as required, specifically, in the Licensee's policies relating to complaints, infection prevention and control, whistleblowing. PASDs, fire and safety, emergency plan and evacuation, behaviour management and resident's bill of rights. The Licensee failed to ensure all staff were trained as required.

Outcome

The Licensee submitted a plan to achieve compliance by Thursday August 31, 2023. RHRA to confirm compliance by following up with the Licensee or by inspection.

Additional Findings

During a routine inspection, an inspector may observe areas of non-compliance that are not related to the standard focus areas. In these cases, an inspector may cite the home for these contraventions at the time of this inspection. In addition, an inspector may follow-up on findings of non-compliance from previous inspections. Where the licensee is unable to demonstrate they have come into compliance or maintained compliance, an inspector may cite the home for these repeat contraventions at the time of this inspection.
