About Responsive Inspections

A responsive inspection, performed by an RHRA inspector, is a physical inspection of a licensed retirement home. A responsive inspection is conducted when RHRA receives information that the licensee may have failed to meet the standards of the *Retirement Homes Act, 2010* or its regulations (the "*RHA*"). An inspection being conducted does not infer that an allegation is substantiated or that a contravention of the RHA has occurred. A licensee is required to report to RHRA if they suspect harm or risk of harm to a resident. During a responsive inspection, an RHRA inspector may observe the operations of the home, interview relevant individuals, review records and other documentation, and determine whether the licensee's management and staff have followed mandatory policies and practices designed to protect the welfare of residents.

Following a responsive inspection, the RHRA inspector prepares a draft inspection report which is sent to the licensee. The draft report may include instances where the licensee has failed to meet the standards of the *RHA*. If included, the licensee can respond to these instances and is strongly encouraged to inform RHRA of its plans to meet the standards of the *RHA*.

Following the draft report, the RHRA inspector prepares this final inspection report, incorporating any response from the licensee with their plans to meet the standards of the *RHA*. The most recent final inspection report must be posted in the home in a visible and easily accessible location. All final inspection reports from the previous two years must also be made available in an easily accessible location in the home. The licensee must provide a copy of this report to the home's Residents' Council, if one exists.

In addition to inspection reports, RHRA may provide information to a licensee to encourage improvements of their current practices.

If there is a serious incident or the licensee repeatedly does not meet the required standards, RHRA may take further action.

Concern(s)

During a responsive inspection, an inspector will focus primarily on the concern(s) which prompted the

inspection and may take various actions to determine whether the licensee is compliant with the RHA in relating to the concern(s). Any findings of non-compliance identified in relation to these concerns are listed below.

Concern #1: CON-7394-Neglect

RHRA Inspector Findings

The Licensee reported to the RHRA an incident of improper or incompetent treatment or care of a resident. As part of the inspection in response to the allegation, the inspector reviewed the Licensee's care policies and procedures, staff training records, the resident's care file, and interviewed relevant staff and witnesses. The evidence confirmed a resident who had fallen had not been checked on by staff when the resident could not be reached by a friend for a routinely scheduled Sunday morning outing and was also not checked on when not present for the day's meals as required by the Licensee's policy. The evidence also showed that when a staff member checked on the resident after receiving an evening call from the resident's friend; and, being advised of having fallen and was on the floor all day by the resident, the apparent neglect had not been reported or investigated. Further, the events were later reported in writing to the Licensee over two weeks later by a family member alleging neglect at which time investigative steps were commenced but the matter was not immediately reported to the RHRA as required. Furthermore, there was no evidence to show staff responsible for implementing the Licensee's policy related to wellbeing checks had been trained in the policy. The Licensee failed to ensure the abuse and neglect provisions had been fully met and that the related policy training had been completed.

Outcome

The Licensee submitted a plan to achieve compliance by February 2, 2024. RHRA to confirm compliance by following up with the Licensee or by inspection.

Additional Findings

During a responsive inspection, an inspector may observe areas of non-compliance that are not related to the concern(s) which prompted the inspection. In these cases, an inspector may cite the home for these contraventions at the time of this inspection. In addition, an inspector may follow-up on findings of non-compliance from previous inspections. Where the licensee is unable to demonstrate they have come into compliance or maintained compliance, an inspector may cite the home for these repeat contraventions at the time of this inspection.

Additional Finding#1: CON-7503-Training

RHRA Inspector Findings

While conducting this inspection, the inspector made a finding unrelated to the purpose of the inspection. The inspector reviewed training evidence and found two of the three involved staff members had either not received the necessary training or had not received annual retraining in the listed items as required. The Licensee failed to ensure the training and retraining provisions had been fully met.

Outcome

The Licensee submitted a plan to achieve compliance by February 11, 2024. RHRA to confirm compliance by following up with the Licensee or by inspection.

The Licensee failed to comply with the RHA s. 65. (2); Training
