## **About Responsive Inspections**

A responsive inspection, performed by an RHRA inspector, is a physical inspection of a licensed retirement home. A responsive inspection is conducted when RHRA receives information that the licensee may have failed to meet the standards of the *Retirement Homes Act, 2010* or its regulations (the "*RHA*"). An inspection being conducted does not infer that an allegation is substantiated or that a contravention of the RHA has occurred. A licensee is required to report to RHRA if they suspect harm or risk of harm to a resident. During a responsive inspection, an RHRA inspector may observe the operations of the home, interview relevant individuals, review records and other documentation, and determine whether the licensee's management and staff have followed mandatory policies and practices designed to protect the welfare of residents.

Following a responsive inspection, the RHRA inspector prepares a draft inspection report which is sent to the licensee. The draft report may include instances where the licensee has failed to meet the standards of the *RHA*. If included, the licensee can respond to these instances and is strongly encouraged to inform RHRA of its plans to meet the standards of the *RHA*.

Following the draft report, the RHRA inspector prepares this final inspection report, incorporating any response from the licensee with their plans to meet the standards of the *RHA*. The most recent final inspection report must be posted in the home in a visible and easily accessible location. All final inspection reports from the previous two years must also be made available in an easily accessible location in the home. The licensee must provide a copy of this report to the home's Residents' Council, if one exists.

In addition to inspection reports, RHRA may provide information to a licensee to encourage improvements of their current practices.

If there is a serious incident or the licensee repeatedly does not meet the required standards, RHRA may take further action.

# Concern(s)

During a responsive inspection, an inspector will focus primarily on the concern(s) which prompted the inspection and may take various actions to determine whether the licensee is compliant with the RHA in relating to the concern(s). Any findings of non-compliance identified in relation to these concerns are listed below.

#### Concern #1: CON-7442-Improper Care & Neglect

#### **RHRA Inspector Findings**

A complaint was made to the RHRA regarding concerns of improper or incompetent treatment or care, and an allegation of staff to resident neglect. As part of the response to the report, the Inspector interviewed the resident and relevant staff and reviewed the Licensee's policies, the resident's care file and various documents related to the concerns. The Inspector found the Licensee failed to report the incident to the Registrar as required and that there was insufficient evidence to support the Licensee investigated the allegation.

#### Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by following up with the Licensee or by inspection.

#### Concern #2: CON-7443-Plan of Care

#### **RHRA Inspector Findings**

As part of the inspection, the Inspector reviewed the resident's care files and interviewed staff. The Inspector found that the resident's care needs changed in the fall of 2023, but the resident was not reassessed, and their plan of care was not reviewed and revised at that time as required. In addition, the Inspector found that the resident's falls risk is not documented in their current plan of care and there is a lack of clear directions to staff for providing assistance with ambulation and dressing to the resident. The Licensee failed to ensure a resident's plan of care was compliant in the noted areas.

#### Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by following up with the Licensee or by inspection.

#### Concern #3: CON-7748-Emotional Abuse

#### **RHRA Inspector Findings**

A complaint was also made to the RHRA regarding two incidents alleging staff to resident emotional abuse. As part of the inspection, the Inspector interviewed the resident and relevant staff and reviewed the Licensee's policies and documents relating to the concerns. The Inspector found the Licensee failed to report the incidents to the Registrar as required and that there was insufficient evidence to support the Licensee investigated the allegations.

#### Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by following up with the Licensee or by inspection.

#### Concern #4: CON-7752-Complaint Management

## **RHRA Inspector Findings**

As part of the inspection, the Inspector reviewed the Licensee's record of complaints and interviewed staff. The Inspector found that while the Licensee investigated two specific complaints, the Licensee did

not fully implement their complaints policy in relation to documentation and the lack of detailed responses to the complainant. Specifically, there is a lack of documented evidence to support the types of actions taken to resolve the complaints, including the dates of the actions, time frames for actions to be taken and any follow up action required and the final resolution of the complaints.

#### Outcome

The Licensee has advised it has taken corrective action to achieve compliance. RHRA to confirm compliance by following up with the Licensee or by inspection.

## **Additional Findings**

During a responsive inspection, an inspector may observe areas of non-compliance that are not related to the concern(s) which prompted the inspection. In these cases, an inspector may cite the home for these contraventions at the time of this inspection. In addition, an inspector may follow-up on findings of non-compliance from previous inspections. Where the licensee is unable to demonstrate they have come into compliance or maintained compliance, an inspector may cite the home for these repeat contraventions at the time of this inspection.
