About Responsive Inspections

A responsive inspection, performed by an RHRA inspector, is a physical inspection of a licensed retirement home. A responsive inspection is conducted when RHRA receives information that the licensee may have failed to meet the standards of the *Retirement Homes Act, 2010* or its regulations (the "*RHA*"). An inspection being conducted does not infer that an allegation is substantiated or that a contravention of the RHA has occurred. A licensee is required to report to RHRA if they suspect harm or risk of harm to a resident. During a responsive inspection, an RHRA inspector may observe the operations of the home, interview relevant individuals, review records and other documentation, and determine whether the licensee's management and staff have followed mandatory policies and practices designed to protect the welfare of residents.

Following a responsive inspection, the RHRA inspector prepares a draft inspection report which is sent to the licensee. The draft report may include instances where the licensee has failed to meet the standards of the *RHA*. If included, the licensee can respond to these instances and is strongly encouraged to inform RHRA of its plans to meet the standards of the *RHA*.

Following the draft report, the RHRA inspector prepares this final inspection report, incorporating any response from the licensee with their plans to meet the standards of the *RHA*. The most recent final inspection report must be posted in the home in a visible and easily accessible location. All final inspection reports from the previous two years must also be made available in an easily accessible location in the home. The licensee must provide a copy of this report to the home's Residents' Council, if one exists.

In addition to inspection reports, RHRA may provide information to a licensee to encourage improvements of their current practices.

If there is a serious incident or the licensee repeatedly does not meet the required standards, RHRA may take further action.

Concern(s)

During a responsive inspection, an inspector will focus primarily on the concern(s) which prompted the inspection and may take various actions to determine whether the licensee is compliant with the RHA in relating to the concern(s). Any findings of non-compliance identified in relation to these concerns are listed below.

Concern #1: CON-7945-Plan of Care

RHRA Inspector Findings

The Licensee reported to the RHRA that a resident had not been administered required medications after being admitted to the home from the hospital. As part of the inspection, the inspector spoke to staff and reviewed documentation and could not find conclusive evidence that the home had been advised that these medications were required. However, the Inspector's review of the resident's medical file revealed several issues with the resident's plan of care. Firstly, the plan of care had not been updated within the required timelines. Secondly, there was no indication the plan of care was developed or approved by a member of the College of Physicians and Surgeons of Ontario or the College of Nurses of Ontario, nor was it approved by the resident or their substitute decision maker. Thirdly, the plan of care was not based on the assessment of the resident and did not include all care services the resident was entitled to receive under the agreement with the licensee. Fourthly there were no details, goals, or clear directions to the licensee's staff regarding the required care services. The Licensee was unable to demonstrate that the plan of care for the resident was revised and completed in alignment with the legislation.

Outcome

The Licensee submitted a plan to achieve compliance by Fri Mar 15 2024. RHRA to confirm compliance by following up with the Licensee or by inspection.

Concern #2: CON-7958-Emergency Plan

RHRA Inspector Findings

As part of the inspection, the inspector reviewed previous areas of non compliance surrounding their emergency plan. The inspector again found the home had not completed testing of the emergency system in the areas of situations involving violent outbursts, medical emergencies, loss of essential services, and pandemics and epidemics, nor had they ensured they had resources, supplies, and equipment vital for the emergency response regularly tested to ensure that they are in working order. In addition they had not completed a full evacuation in the previous 2 years.

The Licensee was unable to demonstrate they had completed the testing of their emergency plan and procedures in alignment with the legislation.

Outcome

The Licensee submitted a plan to achieve compliance by Sun Mar 31 2024. RHRA to confirm compliance by following up with the Licensee or by inspection.

Additional Findings

During a responsive inspection, an inspector may observe areas of non-compliance that are not related to the concern(s) which prompted the inspection. In these cases, an inspector may cite the home for these contraventions at the time of this inspection. In addition, an inspector may follow-up on findings of non-compliance from previous inspections. Where the licensee is unable to demonstrate they have come into compliance or maintained compliance, an inspector may cite the home for these repeat contraventions at the time of this inspection.
