About Routine Inspections

A routine inspection, performed by an RHRA inspector, is a physical inspection of a licensed retirement home. During a routine inspection, an RHRA inspector will walk through the home, speak to residents and staff, observe care services and conditions in the home, and ensure the licensee's management and staff follow mandatory policies and practices designed to protect the welfare of residents.

Following a routine inspection, the RHRA inspector prepares a draft inspection report which is sent to the licensee. The draft report may include instances where the licensee has failed to meet the standards of the *RHA*. If included, the licensee can respond to these instances and is strongly encouraged to inform RHRA of its plans to meet the standards of the *RHA*.

Following the draft report, the RHRA inspector prepares this final inspection report, incorporating any response from the licensee with their plans to meet the standards of the *RHA*. The most recent final inspection report must be posted in the home in a visible and easily accessible location. All final inspection reports from the previous two years must also be made available in an easily accessible location in the home. The licensee must provide a copy of this report to the home's Residents' Council, if one exists.

In addition to inspection reports, RHRA may provide information to a licensee to encourage improvements of their current practices.

If the licensee repeatedly does not meet the required standards, RHRA may take further action.

Focus Areas

During a routine inspection, an inspector will focus primarily on a set number of areas which have been identified as related to the health, safety and wellbeing of resident, and may take various actions to determine whether the licensee is compliant with the RHA in relating to the areas. The areas listed in this section are ones which an inspector has identified as non-compliant.

Focus Area #1: Emergency Plan

RHRA Inspector Findings

As part of the routine inspection, the inspector reviewed the Licensee's emergency plan. The inspector reviewed records of testing for their emergency plans and found that the testing for situations involving violent outbursts, medical emergencies, missing resident, loss of essential service, and pandemic/epidemic plan had not been completed annually. In addition, the Licensee had not conducted a full evacuation of the home. The Licensee had previously been cited for lack of testing of the emergency plan. Finally, agreements with community partners to assist with accommodations and transportation during an evacuation were outdated. The Licensee failed to ensure its emergency plan was in compliance with legislation.

Outcome

The Licensee submitted a plan to achieve compliance by May 10, 2024. RHRA to confirm compliance by following up with the Licensee or by inspection.

Focus Area #2: Resident Record, Assessment, Plan of Care

RHRA Inspector Findings

As part of the routine inspection, the inspector reviewed a sample of resident care plans. There is a requirement that resident care plans are updated as care needs change. The inspector found that not all the plans were updated at the time the residents' care needs changed or every six months. Secondly, three care plans had not been approved by the residents or their substitute decision makers. Thirdly, the Licensee failed to ensure that the development of the assessment and plan of care were completed within the required time frame for three residents. The Licensee had previously been cited on all these matters. The Licensee failed to ensure that resident assessments and care plans were in compliance with the legislation.

Outcome

The Licensee submitted a plan to achieve compliance by April 26, 2024. RHRA to confirm compliance by following up with the Licensee or by inspection.

Focus Area #3: Staff Training

RHRA Inspector Findings

As part of the routine inspection, the inspector reviewed a sample of orientation and annual training records in the areas of zero tolerance of abuse, resident bill of rights, infection control, whistle blower protection, personal assistance services devices, fire prevention and safety, complaints, behaviour management and medication administration. The inspector found some staff did not have annual training records for the mandatory training. In addition, the Licensee did not have accurate records of medication administration training for all staff involved in medication administration upon hire and annual training. The Licensee was previously cited on lack of records for annual training of mandatory topics and medication administration. Finally, there were no records demonstrating staff were trained on the care services offered by the home. The Licensee failed to ensure that staff were trained as required.

Outcome

The Licensee submitted a plan to achieve compliance by May 10, 2024. RHRA to confirm compliance by following up with the Licensee or by inspection.

During a routine inspection, an inspector may observe areas of non-compliance that are not related to the standard focus areas. In these cases, an inspector may cite the home for these contraventions at the time of this inspection. In addition, an inspector may follow-up on findings of non-compliance from previous inspections. Where the licensee is unable to demonstrate they have come into compliance or maintained compliance, an inspector may cite the home for these repeat contraventions at the time of this inspection.
