About Routine Inspections
<p>A routine inspection, performed by an RHRA inspector, is a physical inspection of a licensed retirement home. During a routine inspection, an RHRA inspector will walk through the home, speak to residents and staff, observe care services and conditions in the home, and ensure the licensee’s management and staff follow mandatory policies and practices designed to protect the welfare of residents.</p> <p>Following a routine inspection, the RHRA inspector prepares a draft inspection report which is sent to the licensee. The draft report may include instances where the licensee has failed to meet the standards of the <i>RHA</i>. If included, the licensee can respond to these instances and is strongly encouraged to inform RHRA of its plans to meet the standards of the <i>RHA</i>.</p> <p>Following the draft report, the RHRA inspector prepares this final inspection report, incorporating any response from the licensee with their plans to meet the standards of the <i>RHA</i>. The most recent final inspection report must be posted in the home in a visible and easily accessible location. All final inspection reports from the previous two years must also be made available in an easily accessible location in the home. The licensee must provide a copy of this report to the home’s Residents’ Council, if one exists.</p> <p>In addition to inspection reports, RHRA may provide information to a licensee to encourage improvements of their current practices.</p> <p>If the licensee repeatedly does not meet the required standards, RHRA may take further action.</p>

Focus Areas
<p><i>During a routine inspection, an inspector will focus primarily on a set number of areas which have been identified as related to the health, safety and wellbeing of resident, and may take various actions to determine whether the licensee is compliant with the RHA in relating to the areas. The areas listed in this section are ones which an inspector has identified as non-compliant.</i></p>
Focus Area #1: Emergency Plan

RHRA Inspector Findings

As part of the routine inspection, the Inspector reviewed the Licensee’s records of testing for their emergency plan and interviewed staff. The Licensee was unable to demonstrate that a full evacuation of the home was conducted every two years as required. The Licensee failed to ensure the home’s emergency plan was fully followed.

Outcome

The Licensee submitted a plan to achieve compliance by Friday February 28, 2025. RHRA to confirm compliance by following up with the Licensee or by inspection.

Focus Area #2: Resident Record, Assessment, Plan of Care**RHRA Inspector Findings**

The Inspector reviewed a sample of resident care files and found that initial plans of care were not developed for two residents who recently moved into the home, and a resident's fall risk and their needs related to that risk/strategies to mitigate falls was not documented in their respective plans of care.

Outcome

The Licensee submitted a plan to achieve compliance by Friday February 14, 2025. RHRA to confirm compliance by following up with the Licensee or by inspection.

Focus Area #3: Staff Training**RHRA Inspector Findings**

The Inspector reviewed a sample of new staff training records and interviewed staff. The Inspector found the majority of new staff reviewed had not completed the required training at all or prior to working in the home in the Licensee's zero tolerance of abuse and neglect, complaints and personal assistance service devices policies, the Licensee's emergency and evacuation plan, fire safety, resident's bill of rights, whistleblowing, and infection prevention and control. Further, the Licensee was unable to demonstrate that all new staff selected were trained in the care services offered by the home within six months of hire. The Licensee failed to ensure all new staff were trained as required.

Outcome

The Licensee submitted a plan to achieve compliance by Friday February 21, 2025. RHRA to confirm compliance by following up with the Licensee or by inspection.

Additional Findings

During a routine inspection, an inspector may observe areas of non-compliance that are not related to the standard focus areas. In these cases, an inspector may cite the home for these contraventions at the time of this inspection. In addition, an inspector may follow-up on findings of non-compliance from previous inspections. Where the licensee is unable to demonstrate they have come into compliance or maintained compliance, an inspector may cite the home for these repeat contraventions at the time of this inspection.
